

REGISTRATION AT ST. AUGUSTINE CHS FREQUENTLY ASKED QUESTIONS



1. We live outside the St. Augustine CHS boundary. Can my child apply to the school?

Due to the **enrollment cap** set in May 2025, **St. Augustine CHS will only accept students** who currently reside within our school boundary zone. Please visit this link to determine if your home is within the St. Augustine CHS boundary zone. <u>ST. AUGUSTINE CHS</u>

2. What is the registration process if my child attends one of the St. Augustine CHS feeder schools (All Saints, St. John XXIII, St. Justin Martyr, St. Matthew, St. Monica)?

Students attending a feeder school will receive an individualized registration package in their grade 8 class in November.

3. What is the registration process for students who attend a feeder school but do not live within the St. Augustine CHS boundary? <u>ST. AUGUSTINE CHS</u>

Students must complete a **TCH19a** as per **YCDSB Policy 226B**. This form requires **Board approval** before the registration process can proceed, and **student acceptance is not guaranteed.** Please visit this website for more information Policy-226B-Admission-Secondary-Schools.pdf

4. What is the registration process if my child resides within the St. Augustine boundary, but attends a YCDSB school that is not one of your feeder schools? (All Saints, St. John XXIII, St. Justin Martyr, St. Matthew, St. Monica)

Non-feeder YCDSB students living within the St. Augustine CHS boundary will need to complete the following form no later than **Wednesday**, **November 12th**, **2025**. (https://forms.gle/3GTDKzxpPLPzKupr8)

5. What is the process if my child lives within the St. Augustine CHS boundary, but does not attend a YCDSB elementary school?

Non-YCDSB students must complete the online registration form, which will be available on the St. Augustine website between **November 24th at 7:00 p.m. and November 26th at 7:00 p.m.**

6. What happens when the grade 9 enrollment reaches its maximum capacity for the 2026 - 2027 school year?

Once enrollment reaches capacity, a **waitlist** will be created based on the time at which registrations were received.

7. We currently live outside of the St. Augustine CHS boundary, but will be moving into the area before the start of the 2026/27 school year. Can my child apply to the school?

The admission process offers **first consideration** to students currently living within our school boundary zone. The address provided at the time of application will be used to determine eligibility for entrance. Proof of current residency is required. Students moving into the area will be placed on a **waitlist** and will be considered for admission if space becomes available.

8. What happens if there is missing or incomplete documentation in the registration package?

Due to the high volume of registration requests, applications with missing or incomplete documentation **will not** be accepted.

9. What happens if the application is received after the deadline?

Due to the high volume of applicants, all due dates and document submission deadlines must be strictly adhered to. If your child's application is not submitted on time, the school will proceed with the next completed application.

10. If I have a child who currently attends St. Augustine CHS, will my younger child be considered for admission?

Families with **siblings** may be considered for admission and are advised to contact the guidance office to find out if they meet the sibling eligibility requirement.

11. If my child is not accepted for grade 9, can they reapply for grade 10?

No. Due to the high volume of applications, we only accept students in grade 9.

STREAM Focus Program Questions

1. Can we apply to both the regular academic and the STREAM Focus Program?

Yes, students can apply to both the standard academic and the STREAM Focus Program. Please note, however, that there are **two** separate online applications with different submission dates. Ensure you are ready to apply by the respective deadlines.

2. Can students apply to the STREAM Focus Program if they do not attend a YCDSB school?

Yes, all students within the St. Augustine CHS boundary area are eligible to apply.

5. When will applicants of the STREAM Program be informed if they have been successfully accepted into the program?

Notification of acceptance into the STREAM Focus Program will be sent via email on **Tuesday**, **November 25**, **2025**. **Acceptance into the STREAM Focus Program does not**, **however**, **guarantee registration at St. Augustine CHS**.
